The Changing Role of Primary Care Providers: Understanding and Supporting the Change

The passage of the Affordable Care Act (ACA) confirmed what many health care providers, practitioners, payors, legislators, and academics have long believed — that reorienting the health care delivery system toward primary care is the best approach for making health care affordable and accessible for all Americans, while slowing down the rapid and unsustainable rise in health care expenditures. Reorientation toward primary care requires fundamental changes in the primary care infrastructure and the roles of the physicians practicing within the infrastructure.

The anticipated deficit of primary care physicians coupled with the increase of insured patients who will consume twice as much medical care as uninsured patients points to an imperative to develop innovative models of care and advance the role of the primary care provider. Primary care physicians are rapidly transitioning from caregivers (traditional role) to care coordinators and managers (emerging role) with new, multifaceted responsibilities and different incentives for patient care and health management.



The historical role of primary care physicians has been to provide episodic, fee-for-service medical care in a one-to-one provider-to-patient approach. The new emerging role requires primary care physicians to manage the health of the patient population served, ensuring wellness, access, coordinated care, and high-quality outcomes.

Innovative care models, particularly ones that help leverage physician resources by using new care management approaches, advocating for health promotion and wellness, and optimizing the use of non-physician clinicians will close the gap between the traditional and emerging role of physicians. Teambased care, group visits, telemedicine, and medical homes will become the standard for primary care delivery. Primary care providers will be in the hub of care delivery - employing the novel models and approaches that are necessary to coordinate the continuum of care for a defined patient population.

Health system executives must help primary care physicians successfully adapt to their new roles and incorporate these innovative approaches by


